**COURSES AND BIRDS**

All Stakes will be run on a single course without a bird field. Quail will be released in all stakes except Open Puppy. Native game birds may be found and used on course in all stakes.

Tracking collars are allowed in all stakes, in strict accordance with AKC regulations governing their use. "Use of AKC approved tracking collars is permitted."

Firearms: Blank Guns & Ammunition in accordance with AKC guidelines. No Open Barrels Allowed. A blank cartridge will be fired in Open Puppy stake.

Horseback handling will not be permitted in any stake.

Bitches in season may compete in the Amateur Gun Dog stake.
