NO OPEN BARRELS PERMITTED.

HORSEBACK HANDLING ALLOWED IN ALL STAKES EXCEPT AMATEUR WALKING GUN DOG WHICH IS WALKING ONLY.
WALKING PERMITTED IN ANY STAKE.

Tracking collars are allowed in all stakes, in strict accordance with the AKC regulations governing their use.

Bitches in season may compete in the final braces of the Amateur Gun Dog.

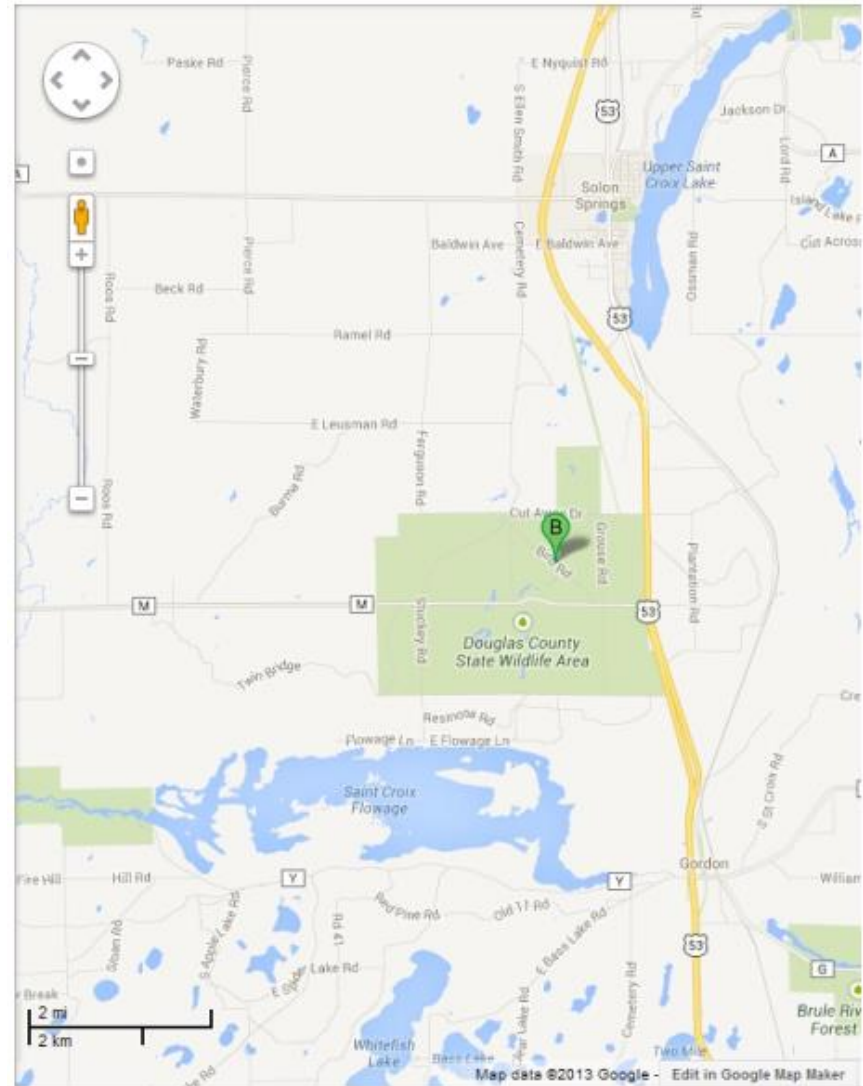
