ALL STAKES ARE SINGLE COURSE WITHOUT A BIRD FIELD. QUAIL RELEASED IN ALL STAKES EXCEPT NO BIRDS WILL BE RELEASED IN THE OPEN PUPPY STAKE. A BLANK CARTRIDGE WILL BE FIRED IN THE OPEN PUPPY STAKE.

NO OPEN BARRELS ALLOWED. HORSEBACK HANDLING ALLOWED IN ALL STAKES. PLEASE INDICATE IF YOU WILL BE WALKING IN A STAKE – WILL BE BRACED WITH ANOTHER WALKING HANDLER (if possible).

Tracking collars are allowed in all stakes, in strict accordance with AKC regulations governing their use. "Use of AKC approved tracking collars is permitted."

Bitches in season may compete in final brace of day, if possible.
Only AKC approved tracking & GPS collar models will be allowed.


Turn right onto 165th Ave SE. Drive 1.5 miles.
